 - Consider the minimum annual budget for operating a court to meet your community needs?

JUDICIAL ETHICS

What are the standards?

NATIONAL AMERICAN INDIAN COURT JUDGES ASSN JUDICIAL CONDUCT AND CODE OF ETHICS

- The Tribal Court Judge is the number one representative of the court. The court's integrity and fairness defines a communities' faith and health in utilizing a tribal court.
- Tribal court judges should not practice law in their own courts, or, in any court subject to the appellate process in which he or she serves.
- A judge should encourage a separation between the judicial branch and other branches of tribal government.
- A judge should not participate in legislative or executive decision making except where it is permitted by the tribe.
- Special care needs to be taken when a judge sits on a tribal council. The appearance or possibility of conflict of interest needs to be avoided.

NAICJA JUDICIAL CONDUCT AND CODE OF ETHICS (2)

- A judge should not participate in cases involving immediate family members, in cases involving someone with whom the judge has a strong personal relationship, or in cases where the judge has a significant, direct, financial, political, or other personal interest.
- A judge should discuss cases and court business only in the presence of all parties.
- A judge has a responsibility to uphold confidentiality and should never discuss a
 case with outside parties or use confidential information acquired in the course of
 their official duties to further their personal interests.
- A judge should be aware that their conduct has a direct bearing on public attitude toward their court and as such, should conduct themselves appropriately.

- Your firm represents many Tribes and Tribal people on a variety of issues including code development, litigation and representation of tribal agencies like Police Departments and Housing Authorities.
- A local Tribe has offered you a position as their Chief Judge of their Tribal Court.

- Are these considerations the same if you are not admitted to practice law in CA?

- Tribal Leadership

- Legal Counsel

WHAT IS THE TOPIC

- An ongoing case
- Court Policies & Procedures
- Politics
 - A recent leadership decision
 - Upcoming elections
- Is it a matter that is or may end up in Tribal Court?

WHEN & WHERE IS THIS CONVERSATION

- In Court on the record
- At work, on the clock, but off the record
- Running an errand, off the clock
- At a group function [maybe even on someone else's clock?]
 - A conference
 - A cultural event

WHY IS THIS CONVERSATION HAPPENING

- Is a party relaying/reporting information about the case?
- Is it to set or improve policy?
- Is it to report to a group about the Court?
 - Report to Tribal Council
 - Elders Council
 - Town Hall

HYPOTHETICAL #2

- You are a lawyer licensed to practice law in the state of California.
- You have represented tribes for years in various matters of tribal concern.
- Along the way you have accumulated many colleagues, a few have become confidants and trusted friends.
- You are now a Tribal Court Judge, congratulations.
- One of your most trusted colleagues calls you to vent about a case in a different Tribal court.
- The discussion is in hypothetical terms, no names, not even of the tribe.
- Your friend then asks what you would do if it was your case?

ACCEPTING GIFTS

Monetary, Cultural, Ceremonial

GIFTS

- Can Judges accept gifts?
- It will depend on your community's standards
- Monetary Value Ex: Starbucks Gift Card
- Cultural Ex:Traditional Necklace
- Ceremonial Value A plaque or a framed certificate

HYPOTHETICAL #3

- You are a Tribal Court Judge. Again, congratulations.
- Traditionally the Tribe you work for has allowed ceremonial gifts of appreciation.
- Recently, you helped resolve a long lasting dispute amongst community members.
- Some of the community members have purchased you and your family tickets to a local amusement park.
- There is no explicit rule against taking monetary gifts, nor is there one explicitly permitting it.
- Can (and should) you take the tickets and go ride some roller-coasters with the kids?
